- b. Equipment expenses
 - i. Josh presented that the New Holland front tracks need repair. Cost is \$3,725 plus freight each to rebuild. Much discussion was had and we feel this is a priority of the club to maintain the integrity of our main grooming unit.  - ii. Josh also presented to the club of his research to obtain a different drag that would be easier to operate and potentially do a better job in certain applications on the trail. Josh's research showed that the drags that have had the best success are around \$30,000. Josh obtained quotes for materials and believes he can build for around \$10,000. He is willing to build and donate his time. After much discussion, it was decided to take advantage of Josh's abilities and the cost savings by approving the spending for materials for Josh to build a new drag. Kenny Hopfensperger made motion; David Moon 2nd; motion carried.
